1. ONE-TIME USE (CONNECT)

	Charged for each use of the Service by the End User	Annual subscription for the End User, irrespective of the number of use.

2. IDENTIFICATION SERVICES (IDENTIFY, IDENTIFY PLUS, IDENTIFY AML)

Annual subscription of the End User.

The IDENTIFY, IDENTIFY PLUS, IDENTIFY AML and SIGN Services also include an annual subscription to the CONNECT Service.

The price of the Service is charged as a one-time fee upon data transfer, updates (e.g. change of surname) are free of charge during the subscription period. After the subscription period expires, the next payment is only charged when the End User next uses a Bank iD Service.

When upgrading to a higher variant (e.g. from the CONNECT Service to the IDENTIFY Service), only the additional price will be charged. Hence, the value of the additional payment per User is determined by the price of the newly subscribed Service less the pro rata portion of the subscription price of the original Service for the remaining term of the existing subscription. Further, the duration of the new annual subscription is calculated from the date of subscription to the higher level of Service.

3. SIGNATURE / AUTHORIZATION

The SIGN service can only be used with the other Services which are necessary for its provision, i.e. with the CONNECT service or IDENTIFY, IDENTIFY PLUS or IDENTIFY AML Services. The resulting price of the Service is therefore created by the sum of the price of the particular Services necessary for provision of the SIGN service as follows:

- the sum of the one-time use or subscription price for the CONNECT Service and the price for the SIGN Service as set out in the table above; or
- the sum of the subscription price for the IDENTIFY, IDENTIFY PLUS or IDENTIFY AML Services and the price for the SIGN Service, as set out in the table above;

depending on which Service the Customer uses together with the SIGN Service.

If the SIGN Service is used during an active subscription to any of the above-mentioned Services, the Customer only pays the price for the SIGN Service.
